# **EXECUTIVE SUMMARY**

Oversight of the management of institutional asset pools, including foundations, endowments, retirement plans, corporate assets and reserves, is becomingly increasingly complex and challenging. - Maybe you have some expertise on your staff or committee to develop questions, but would like to complement that to be fully effective
- Perhaps you simply recognize that you know what you don't know

# **KEY CONSIDERATIONS**

- A qualified consultant can review what you have and offer suggestions
- A consultant with extensive search experience can provide content that you may not have considered otherwise
- The consultant may have a sample RFP to share
- Leveraging a consultant's database on the firms to be solicited can provide baseline information, so that the questionnaire can focus more on the specific goals and needs of your institution, and facilitate a smoother process



# FINALIST MEETING AND EFFECTIVE DECISION MAKING

Soliciting feedback from OCIO firms via a questionnaire is one thing, but conducting effective finalist meetings and producing the important decision can be quite another. This stage is critical for the staff and committee conducting the oversight to be focused on the strategic review and determining the best fit. You may benefit from utilizing a consultant for this phase.



### **KEY STAKES**

- There is a need for education, guidance and leadership throughout the due diligence process, especially given the likely differences in knowledge and skills of your staff and committee
- Thorough due diligence takes a fair amount of time and effort
- The finalist meetings are utilizing the precious time of your staff and committee members, many of whom may be external and / or senior professionals
- Most finalist meetings take place over an hour timeframe, and this time needs to be highly efficient to facilitate the strategic assessment that leads to an effective decision

#### **KEY CONSIDERATIONS**

- The consultant can perform the heavy lifting so the staff and committee can focus on the strategic review & identifying the best fit OCIO
- The consultant can lead the finalist meetings, including the scheduling, preparing the agendas, obtaining and reviewing the presenters' materials in advance, and prepping the firms to make the best use of the short time together
- The consultant can provide the necessary follow-ups, including reference checks



- An effective consultant will be well versed in consensus decision making - leading discussions, assessments & scoring, which drive towards decision making
- A consultant provides objectivity, being able to treat all firms equally & neutrally
- A skilled consultant will also follow-up with the firms not advancing to share feedback and to maintain solid relationships with them, especially important if these firms have other relationships with your institution



#### CONCLUSION

Even though you may choose to proceed with your oversight efforts in part or in whole internally, you could still benefit from accessing a consultant's expertise to assist with some of your due diligence process. By leveraging a skilled consultant to assist even with some of your program, you increase the likelihood of making the process most efficient and leading to effective decision making.
